Message from the Chair of the Community Redevelopment Agency

On behalf of the city of Clearwater's Community Redevelopment Agency (CRA), I am pleased to provide the Annual Report for Fiscal Year 2019/2020 which ended on Sept. 30, 2020. Throughout the report, you will find examples of the CRA's adopted 18-month strategy, which aimed to foster a downtown that will become a great destination in which one can live, work, and play.

In a year that became defined by the COVID-19 pandemic, we saw our community's resiliency in several ways. The CRA launched its COVID-19 Recovery Program, including participation in the city of Clearwater Back to Business Grant and Professional Services Program, as well as a voucher program to encourage residents to support local businesses. The CRA also worked with the city to close a portion of the downtown core on Cleveland Street, enabling merchants and visitors to engage in outdoor and physically-distanced dining and shopping.

The CRA is continuing its support of local businesses and the beautification of downtown with façade and building improvement grants for tenants and property owners, and issued a Request for Proposals (RFP) for enhanced streetscape lighting along Cleveland Street. To help drive foot traffic in downtown, the CRA also approved an agreement for new rental housing units and solicited an RFP and letters of interest for various sites throughout downtown.

This year, the CRA continued to hold significant arts and civic engagement programming. The CRA finished its lease at Second Century Studios in 2019 with exciting and engaging public programs, and in 2020 released a call for artists for the second iteration of the Downtown Clearwater Mural Program, launched a virtual arts tour featuring more than two dozen public art sites throughout downtown, and welcomed the tenth season of the Sculpture360 program on Cleveland Street. Finally, the CRA held various public meetings throughout the city on the Imagine Clearwater project and Streetscape Phase III, two capital improvement projects that will transform downtown's waterfront and gateway into people-first, vibrant and welcoming public spaces in the heart of our city.


The CRA trustees and staff look forward to continuing our work to foster a lively, engaging downtown Clearwater CRA district that helps redefine coastal living in Florida.

- Approved an interlocal agreement between the Community Redevelopment Agency and the city of Clearwater Police Department to provide additional community policing in the Community Redevelopment Agency district. (\$186,291)
- Approved an interlocal agreement between the Community Redevelopment Agency and the city of Clearwater to provide the CRA with staffing, information technology services and telephone services. (\$500,000)
- Approved a grant agreement with Ruth Eckerd Hall, Inc. to produce Blast Friday festival series in Downtown Clearwater. (\$100,000)



Play

- Provided 2,500 vouchers for a \$20 credit towards a resident's bill at participating downtown restaurants, cafés and bars during nights and weekends from July to September 2020 through the Dine in Downtown Summer 2020 program.(\$25,000)
- Partnered with the Clearwater Arts Alliance to develop a virtual map of downtown's arts assets, featuring more than two dozen murals, sculptures, and creative placemaking projects. https://downtownclearwater. com/arts-and-culture-tour/
- Hosted the second annual Holiday Extravaganza, a series of events including outdoor movies, performances, and holiday decorations, throughout Downtown Clearwater. (\$46,408.89)
- Hosted a three-week exhibition with The Urban Conga on "play," providing hands-on opportunities for residents and visitors to learn creative ways to make cities more engaging, at Second Century Studios. (\$25,000)
- Hosted HO(ME), a limited-run exhibition that examines the concept of "home" and its meaning for individuals and community through the visual arts, at Second Century Studios.
- Began a temporary closure along the 400 and 500 blocks of Cleveland Street in May 2020 to aid restaurants through the COVID-19 pandemic and allow for more social distanced dining and shopping.
