



CCCL Post-Storm Public Information Handout

Emergency Permitting Guidance for Local Governments, State Agencies and Public Utilities

In response to widespread property damage and other emergency conditions created by coastal storms, the Florida Department of Environmental Protection (DEP) issues Emergency Final Orders (EFO) that establish emergency permitting procedures seaward of the state of Florida Coastal Construction Control Line (CCCL). These procedures cover post-storm recovery activities such as removing storm debris, making structural repairs, bringing in beach compatible sand and installing temporary coastal protection structures. Under the EFO, local governments, state agencies and public utilities are approved to conduct specific storm recovery activities without the need for an individual CCCL permit. In addition, CCCL emergency procedures provide a role for local governments to help expedite post-storm coastal construction permitting. CCCL permits are not required for certain recovery activities by private entities that have been properly permitted by a local government under the conditions of the EFO.

This document details CCCL emergency permit requirements for local governments, state agencies and public utilities engaged in post-storm response and recovery. Emergency procedures are detailed by activity in [Table 1](#), including a description of the work, location of the work, type of emergency permit, exemption or other authorization that applies to the activity, and the conditions under which the activity must be conducted. The state of Florida's regulatory authority over these activities is from [Sections 161.053 and 161.085, Florida Statutes\(F.S.\)](#), [Rule Chapter 62B-33, Florida Administrative Code \(F.A.C.\)](#), and sections C. 3., a. and b. of the EFO issued by the Department for [Emergency Authorization of Repairs, Replacements, Restoration and Certain Other Measures](#) issued for each major storm.

Activities not approved under Post-Storm Emergency Permitting Procedures

The Department EFO for post-storm work seaward of a CCCL does **NOT** approve:

- construction of permanent structures that did not exist prior to the emergency;
- installation of geotextile containers as the core of a reconstructed dune for the purposes of temporary armoring;
- beach scraping or obtaining sand from the beach, near shore, or below the mean high water line seaward of a CCCL without specific authorization from the Department;
- harm to endangered or threatened species of wildlife such as nesting sea turtles or shorebirds;
- repair, replacement, or reconstruction of any type of unauthorized or illegal structure;
- other structures and activities listed in the [section h. of Table 1](#) below titled "WORK SEAWARD OF A CCCL NOT AUTHORIZED UNDER EMERGENCY PERMITS."

Temporary Coastal Armoring and Emergency Permit Notification Requirements

Governmental entities must notify the Department's Office of Resilience and Coastal Protection within three (3) working days of issuing emergency permits under the provisions of the EFO and of installing or authorizing the installation of any armoring pursuant to section C. 3. a. (4) of the EFO and Rule 62B-33.0051(5)(l), F.A.C., with an email to CCCL@FloridaDEP.gov including:

1. A description of the structure, including a sketch and location;
2. The name and address of the property owner; and,
3. The date of installation.

Sand Specifications

Sand from storm overwash deposits returned to the beach and dune system, and sand used to restore grades or dunes must not cover storm generated or construction debris. No sand may be obtained from the beach, near shore, or below the mean high water line seaward of the CCCL without written Department approval. Fill sand for dune restoration or restoring ground elevations and grades must be from an upland source and meet the Department's [Post-Hurricane Recovery Sand Specification](#).

Coastal Wildlife Conservation

Prior to entering the beach, all work within sea turtle nesting season on sea turtle nesting beaches, including the frontal dune, or within shorebird or seabird habitats **must** be coordinated with the Florida Fish and Wildlife Conservation Commission (FWC). The nature, timing, and sequence of recovery activities must be conducted in such a manner as to provide protection to, and so as to not disturb, dune features, native salt-resistant vegetation, and listed species and their habitat, including threatened or endangered sea turtles, endangered manatees, endangered beach mice, endangered plant communities, and migratory shorebirds. The Department's EFO and emergency permits do not authorize the taking, attempted taking, pursuing, harassing, capturing or killing of any species (or the nests or eggs of any species) listed under Rule 68A-27, F.A.C., or the federal Endangered Species Act.

Sea turtle nesting season is May 1 through October 31, or for Brevard, Indian River, St. Lucie, Martin, Palm Beach and Broward Counties, March 1 through October 31.
